

offers a great place to watch these magnificent butterflies. 2 https://www.monarchwatch.org/tagmig/



### New Range Pathway Installed

Club members using the 75-yard to 300-yard ranges will notice that a new pathway was recently installed. The pathway winds its way past each target house out to 300-yds.

The new surface will keep the golf cart clean and safe from off-road damage.

Please continue to follow all range rules and directions on using the golf cart while keeping the golf cart on the new pathway and not off-roading with the cart anymore. That means **when you pull up to a target house, please keep the cart on the pathway** and walk your targets over to the target house.

**Thank you to our caretaker George** for coordinating this range improvement and for tolerating all the over-night construction trucks! This is another fantastic addition to our shooting ranges.



### **Trap House Improvements**

A group of club members recently volunteered to make some erosion prevention improvements to trap house #2. This is the trap that club members who become certified in trap operations are allowed to use daily.



#### Patterning Your Hunting Shotgun at SCFHC

September is a perfect time to get ready for the upcoming hunting season by patterning Ol' Blue.

Not all shotgun shells strike alike. Ammunition companies use different shot and wad materials that have different results when exiting your particular shotgun thus affecting your pattern kill-zone. An hour spent patterning your shotgun at SCFHC can help you to identify the best brand, choke, and shot size for your particular hunting shotgun thereby increasing your bag percentage.

Follow our club range rules in order to test different brands, powder loads, chokes, and shot sizes in your hunting shotgun so you are confident this coming hunting season.



Following all current club range rules, gather your shells and shotgun in a **center booth** of our 25 or 50-yard ranges. Only use booths 3 or 4 on the 25-yd range, or booths 2 or 5 on the 50-yd range. This will prevent pellet / wad damage to the target houses and barriers.

Simply write the shotgun name and specific shot shell information on the target paper to keep track of the data.



Ensure that you **raise the outer doors at a more extreme angle than what you would normally raise it** to when shooting other firearms. This extreme angle will help prevent any damage that might occur from the shotgun wad.





Place your target frame into the center stanchions. This is the same procedure for testing deer slugs, buckshot, and birdshot.

By using only the center booths of the 25-yd & 50-yd ranges for patterning, you prevent damage to the target houses and structures.

Our new rifle rests are a great tool to use in patterning your shotgun, so take advantage of these club shooting aides.

Take two shots using the same branded ammunition at the target, then go out and exchange your target paper, fire two rounds of the next brand of ammunition. Repeat until you've patterned all your different brands of ammunition and preferred chokes.



Finally, divide your target into quarters. Then using a sharpie, simply mark & count the number of strikes in each quadrant to give you an idea of how that particular brand of shell patterns in your shotgun. You may be amazed to see that the brand of shot you've been using all these years is not giving you the best "vital area" pattern.

#### **Atlantic Flyway Mallard Reduced Bag Limit**

Biologists with the Atlantic Flyway Council have recommended to the US Fish & Wildlife Service that a reduced bag limit on the mallard duck be imposed within the Atlantic Flyway for the 2019-20 hunting season. The biologists determined that a 60-day hunting season with a 4-mallard per day harvest was unsustainable and have recommended the daily harvest be reduced to 2-mallard per day,

only one of which may be a hen mallard.

Despite what you may see at your local park, the eastern mallard populations in the United States have declined 38% over the past 20 years while mallard populations in Canada have remained constant. Biologists estimate that the mallard breeding population just within the eastern U.S. will continue its 1% per year decline thus prompting the reduced bag limit recommendation.

To emphasize the importance of the new bag limit, the Atlantic Flyway Council's brochure (above link) states "eastern mallards are now only marginally more abundant than American black ducks in eastern North America."

The final paragraph of the Atlantic Flyway Council's brochure describes how the population of the eastern mallard duck will no longer drive the length & total bag limit of

future hunting seasons due to the declining population. It goes on to explain how the Adaptive Harvest Management strategy is now used to determine the duck hunting season framework by factoring in four key duck species: green-winged teal, ring-necked, goldeneye, and wood ducks.



The reduced mallard daily bag limit coupled with the reduced daily bag limit of the Atlantic Population Canada goose (1-goose per day) will test the resolve of the most hardened waterfowler this season. There is a lot of work in setting up decoys but hopefully this effort

increases the populations.

Over the years, I passed on eating waterfowl that contained "rice breast" and although it is claimed to be safe for humans, I trashed the ducks that we bagged which had the parasite. But the new

reduced bag limit may force me over the psychological hurdle and eat the sarcocystis infected mallard breast like the one pictured (right) that I shot during the 2018 waterfowl season.





## The Master Naturalist

Sika deer hunting has been showing a marked increase in popularity over the past few years among Maryland hunters as well as those in our neighboring states. Information about them online is relatively limited, so here are a few facts about them that address the most common questions we receive;

- Sika deer are actually a member of the elk family.
- They were introduced to the U.S. on James Island (Dorchester County) by Clement Henry in 1916.
- Sika deer keep their spots throughout adulthood, although they may become much less prominent during the fall and winter months.
- Mature Sika males are called 'stags' and mature females are called 'hinds'. The average stag weighs about 90lbs, about the same weight as the average yearling White-tailed doe.
- Sika deer are found in the following counties: Dorchester, Wicomico, Somerset & Worchester, as well as Assateague Island.

## HUNTING SIKA DEER

There are many similarities between hunting Sika deer and hunting white-tailed deer, but there are also many differences as well. Some of these differences include:

- Habitat: Sika deer live primarily in marshlands, swamps, wetlands and some thick pine forests. The largest concentration of them resides in the marshes of Dorchester County.
- The Sika rut is usually during the month of October. During this time, you'll hear the eerie bugle emitted by the stags.
- Shot placement will be similar to white-tailed deer, though the stomach of the Sika deer extends closer to their vital area and should be avoided if possible.
- Sika deer are nicknamed 'marsh ghosts' for a reason; they are extremely quiet as they move.
- They urinate in the scrapes they create, resulting in a strong, musky odor that is very distinctive.

#### Hunting In Maryland

- Sika deer are plentiful at Blackwater National Wildlife Refuge in Dorchester County, of which most allows for public hunting of Sika deer with the appropriate permit. See the link below for details: https://www.fws.gov/nwrs/threecol umn.aspx?id=6442454880
- Blackwater NWR is also home to the largest population of the Delmarva Fox Squirrel. Though removed from the Endangered Species list in 2015, there is no open season for them, so squirrel hunters should be sure of their target before shooting.



Maryland Squirrel season begins September 7<sup>th</sup> and runs until February 29<sup>th</sup>. Includes Gray, Eastern Fox, Red, and Piney Squirrels.

## Legislation

### Maryland

On August 6<sup>th</sup>, the Maryland State Police (MSP) issued a new standard operating procedure (SOP) for carry permits. The MSP also announced that carry permits for business owners will no longer be issued with restrictions. The typical restriction stated carrying was permitted only "while conducting business." The individual must still have a "good and substantial reason" to obtain a permit.

The lifting of restriction does not apply to employees of businesses, only the business owner.

It appears the lifting of restrictions on business owners will be applied to those individuals who have an appeal pending on a permit application and those already issued permits with "while conducting business" restriction. If you have an appeal pending, it is recommended you call the MSP. If you already have a permit with the restriction, it is recommended that you submit a modification request as outlined on Page 4 of the MSP announcement.

As one might expect, the *Baltimore Sun* has come out highly critical of the MSP change in policy. In an August 8<sup>th</sup> editorial, the newspaper stated that lifting the restrictions will put more guns on the street, Quoting "...we believe a profusion of concealed carry permits is a recipe for more accidents and more frequent escalation if disputes to bloodshed..." The editorial also attacked Governor Hogan and asked that he direct the MSP to cancel their new SOP. So we can expect quite a battle in the General Assembly come January 2020.

#### New Anti-gun Organizations

The ant-gunners have been very active on a number of fronts. First, there are new anti-gun groups being formed in various states by the Giffords who previously have backed a number of anti-gun organizations. The new organizations are called "**Gun Owners for Safety**" and supposedly consist of "gun owners who support commonsense gun safety laws."

Literature from an organization in Minnesota states the mission of the organization is: "To support commonsense gun violence prevention laws while respecting the Second Amendment and promoting gun safety." However, the organization supports Red Flag or Extreme Risk Protection Orders, Universal background checks, and Federal funding for "gun violence research."

The "Gun Owners for Safety" organizations are nothing more than gun control groups masquerading as supporters of the Second Amendment and gun safety. If you get literature from any such groups, don't be fooled into giving them a donation.

#### **National Political Scene**

Recent political polls suggest the Democratic front-runner, Joe Biden, is losing ground to Senator Elizabeth Warren of Massachusetts. She is a very liberal candidate in many respects. Recently, she announced a sweeping gun control plan that includes:

- Stricter background checks - Ban on assault weapons - Creation of a Federal licensing system

- Limiting the number of firearms a person could buy and raising the minimum age for gun purchasing to 21

- Holding gun manufacturers, and in some cases gun manufacturer CEOs personally reasonable for the misuse of firearms

- Raising the taxes for gun manufacturers to 30% and taxes on ammunition from 50%

- Providing annually \$100 million of Federal funding for gun violence research.

She also wants Walmart to stop selling guns and ammunition. So if you want to kiss your firearms "good by" vote for Elizabeth Warren.

## Legislation

### **U.S.** Congress

The Congress returns from its August break next week and the pressure will be on the President of the Senate, Mitch McConnell and the other Republican members of the Senate to pass bills like House Resolution (H.R.) 8 and H.R. 1112, two anti-gun bills passed earlier this year by the Democratic-controlled House of Representatives.

H.R. 8 would require universal background checks thereby extending background checks to private sales or transfers of firearms. It would also make loaning a firearm to a friend a Federal crime. https://www.congress.gov/bill/116th-congress/house-bill/8/text

H.R. 1112 would extend from three days to 10 days, and possibly another 10-day period that the FBI would have to respond to a NICS background check before a dealer could release a firearm to a purchaser. The Bill is an attempt to delay firearm sales indefinitely.

In addition, the House Judiciary Committee Chairman called his committee back early from the August recess to consider yet additional gun control bills.

It is going to be fight we have never seen before, and there will be requests to call our Senators and Representatives as well.

It will be an "all hands on deck" fight.

#### All Gun Shoot

**Rifle-** 20 shots with any Maryland legal deer rifle. No shooting equipment is allowed except a scope & sling. Seven shots will be taken offhand (standing) at 100-yards, seven shots from the kneeling position at 150-yards. And six shots will be taken in the prone position at 200-yards.

Shotgun- Shooters will complete one round of 16-yard trap using any trap range eligible shotgun.

Club certificates will be awarded to the top three shooters.
